What's wrong with these pictures?

Circa 1996 – The Clinton campaign accepts campaign contributions from Chinese citizens in clear violation of federal campaign finance laws. Vice President Al Gore appears at a campaign fundraiser at a Buddhist temple in California, raising \$45,000. Temple officials admit to destroying donor records to avoid embarrassing the temple. A hue and cry is heard across the fruited plain. Clinton supporters refer to it as a Vast Right Wing Conspiracy. The Clinton team says, in essence, "let's change the rules." Media and other do-gooders call for campaign finance reform.
